The DSE Assessment provides an accessible starting point to improve worker health related to DSE. Upon successful completion, workers will be able to assess their workstation and prepare a risk assessment based upon its configuration and their own personal requirements. Ensuring maximum comfort and long-term safety.

The course is specifically designed to streamline understanding of the various areas of risk surrounding DSE, being an experience which can be quickly absorbed while remaining memorable.

## What can I do?

You will have the confidence to correctly evaluate your workstation and will have the ability to perform and prepare a Risk Assessment based on your personal DSE circumstances.



# Manual Handling Awareness Course

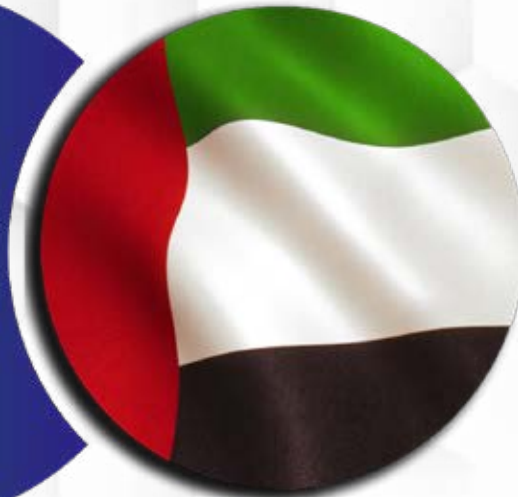
